If you wish to be notified of the decision of the TOWNSHIP OF CHISHOLM COMMITTEE OF ADJUSTMENT, in respect of the proposed consent, you must make a written request to the Township of Chisholm Committee of Adjustment, 2847 Chiswick Line, Powassan, ON, POH 1ZO, by the specified deadline above. This will also entitle you to be advised of a possible Ontario Land Tribunal Hearing.
